### Attendee Release & Waiver

For the 2020/2021 Dance Season

#### Includes Covid19 Guidelines and Health Declaration

By signing this Waiver and initialing the daily "Sign-in Sheet", I understand and agree with the following conditions concerning my attendance at the Dance North (DN) drop-in sessions, held at the YMCA Highland Centre, 155, McDermid Drive, Prince George BC. I agree to this document being held in confidence for future reference for the duration of the dance season.

This release is intended to discharge DN and the YMCA, its members, employees and volunteers from and against any liability arising out of, or connected with, my participation in the dance activity, and I accept any liability which may arise out of the negligence, or carelessness on the part of the entities mentioned above.

I further understand that injuries and accidents can arise out of this activity. Knowing the risk, I hereby agree to assume those risks and to release and to hold harmless the persons mentioned above who, through negligence or carelessness, might otherwise be liable to me, my heirs or assigns for damages.

I am also aware of the circumstances and liabilities with regard to Covid 19 and how it might affect me as a result of social activity.

#### Health Declaration:

*"I hereby declare that: I have not knowingly been in contact with anyone who is currently ill or may have the COVID19 viral infection, I have not traveled here from any other country within the last two weeks, I feel 100% healthy and have no signs associated with the COVID-19 virus, I have read the Dance North Covid-19 Regulations and pledge to follow all these rules to the best of my ability.*

*Confirming this declaration and signing indicates my support of these documents. I understand that attending DN drop-in sessions is a privilege and a breach of any of the rules may result in a suspension of this privilege. If I feel ill or contract the COVID-19 viral infection at any time post the signing of this document, I will not attend DN drop-in sessions and will notify a member of the Dance North immediately. I am aware of the risks, and attend dance sessions at my own risk."*

It is further understood and agreed that this waiver, its release and the subsequent assumption of risks is to be binding on my heirs and assigns.

**Release and Waiver.** Attendee does hereby release and forever discharge and hold harmless, DN and the YMCA and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from any liability or claim that the Attendee may have against DN and the YMCA with respect to any bodily injury, personal injury, illness, death, property damage or property loss that may result from Attendee's activities at or with DN and the YMCA, whether caused by the negligence of DN and the YMCA or its members, employees, agents or otherwise. Attendee also understands that DN and the YMCA does not assume any responsibility for, or obligation to provide, financial assistance or other assistance, including but not limited to, medical, health or disability insurance in the event of injury or illness.
